

Unitarian Universalist Society of Geneva (UUSG) Children and Youth RE Program Participation Agreement

By registering my child for UUSG's RE program, I represent that I am the parent or legal guardian of each child named in the registration form, and I agree to the following on behalf of myself, any co-parent or guardian, and each registered child:

1. I grant permission for my child to participate in UUSG's RE program. For children in the K-2 classes and above, I understand that the program may include short walking field trips in the local area. I give permission for my child to participate in such trips off of UUSG premises.

2. I will ensure that our family is registered in UUSG's Realm database and that our profile information, including but not limited to contacts and emergency contact information, is kept up to date.

3. Our family will comply with the Family Expectations for the RE Program, available [here](#) and posted on the RE Bulletin Board in the Common Room.

4. I understand that my child is expected to comply with the Expectations for Children and Youth, available [here](#) and posted on the RE Bulletin Board in the Common Room. I have reviewed these expectations with my child. I understand any child who engages in dangerous or disruptive behavior or who otherwise fails to comply with these expectations may not be permitted to participate in RE activities or programs, at the discretion of the RE Team.

5. For children in the nursery through middle school, I understand that I or another parent/guardian must be on church premises at all times that my child is participating in RE programs or activities, other than off-site field trips, overnights, or other special events, for which there will be separate permission forms.

6. If my child is participating in the middle school or high school programs (grades 6 through 12) I authorize UUSG to allow my child to leave their RE activities to meet me without me picking them up at their classroom. I will meet my middle school child at a location on church premises. If I am not on church premises while my high school child participates in RE activities, I will be solely responsible for ensuring that they have transportation to and from church.

7. I understand that UUSG is not responsible for supervising my child except during posted RE class and activity times. I am solely responsible for ensuring that my child is adequately supervised before and after RE classes and activities.

8. I understand that UUSG may take photos and video/audio recordings of RE classes from time to time to share within the UUSG community and for use in advertising and promoting our programs, the church, and for fundraising purposes. This may include sharing photos and video online, including in our Realm online community, on Facebook or other social media platforms, the UUSG website, in printed materials, or in any other physical or electronic media or platform. If I do not want my child's likeness to be used for these purposes, I can opt out by completing and returning a "Photo/Video Opt-Out Form" to the UUSG Office. 9. If my child is injured or becomes ill while participating in any RE program or activity, I authorize any UUSG volunteer to administer first aid treatment to my child. I give my permission for my child to receive any needed medical care and treatment required in my absence. I understand that I will be responsible for any expenses associated with such care.

10. I agree to indemnify, protect and hold harmless UUSG, its Board of Directors, its employees, and its volunteers from any claim, loss, or liability whatsoever, including, but not limited to, personal injury, property damage, attorneys' fees, court costs, and interest, arising in whole or in part out of my / my child's participation in any RE program or activity. In addition, I fully release and discharge UUSG, its Board, its employees, and its volunteers from any and all claims from injuries, including death, damages, support, or losses which may arise in whole or in part out of my / my child's participation in any RE program or activity.
